Congratulations! In their meeting on 15 September 2016 the PWYP Global Council and board approved the affiliation of your coalition, Hakirasilimali, to Publish What You Pay (PWYP)! This means that HakiRasilimali is now the affiliate PWYP Tanzania coalition. You have joined an illustrious family of transparency fighters, united in their quest for an open and accountable extractive sector through campaigns, joint advocacy, information sharing and solidarity.

The breadth of the Publish What You Pay coalition is one of our strengths and we are delighted to have yet another coalition coming on board to work with us. We look forward to working with you towards our shared vision 20/20 of a world where all citizens benefit from their natural resources, today and tomorrow.

As the newly affiliated coalition of PWYP in Tanzania, you are already in touch with PWYP through your PWYP Regional Coordinator, Carol Kiangura, who has been supporting you in your application. This letter will give you an overview of the coalition as a whole.

Publish What You Pay has coalitions in more than 40 countries with more than 700 member organisations working towards a more transparent extractive sector. Below you will find some more information about the Publish What You Pay strategy and tools and resources that we hope will be of use to you in the future.

### **Vision 20/20**

Vision 20/20 is the current strategy of Publish What You Pay. It was adopted at PWYP's Tenth Anniversary Conference in 2012 after a year long participatory development process.

The strategy includes four strategic pillars:

- **Publish why you pay and how you extract:** this pillar covers the steps of the value chain before company payments are made, that determine whether citizens are getting a fair deal for their resources;

## PUBLISH WHAT YOU PAY

- **Publish what you pay:** this pillar focuses on the financial transparency of payments made by extractive companies to governments;
- **Publish what you earn and how you spend:** this pillar covers civil society's role in ensuring that natural resource revenues reach the state and are spent responsibly;
- **Practise what you preach:** this pillar covers the governance principles and standards, membership standards and financial reporting mechanisms that ensure the integrity and reliability of the coalition.

We will work closely with you to develop a national strategy using the PWYP value chain (Chain for Change) and the strategic pillars approach. Of important note are the operating principles and membership standards contained within Vision 20/20 (particularly in the Passport document).

Updates can be sent to the Secretariat via your regional coordinator. We also have a mailing list on gender equality in the extractives so please let us know if you would like to be added to this list.

We also have regular electronic newsletters in Arabic, French, Russian and English. You are automatically added to these newsletters as they give you a good overview of the coalition's work and activities. We strongly urge you to contribute by sending us interesting articles on your coalition's work.

### **Mailing List**

Our mailing lists, operated via Google Group, are also an excellent way to keep in touch with other members, particularly within the wider coalition. They allow us to share interesting and relevant resources quickly and easily and we encourage all of our members to use these lists as much as possible to share and learn. You will be added to the group for your region. Please send a list of all your members to your regional coordinator so that they can also be added to the group if you have not already done so.

As part of the membership standards you are required to set up a national mailing list, subscribing all your members as well as the regional coordinator and a member of the Secretariat. If such a group already exists for your coalition, we simply ask you to add the regional coordinator.

### **EITI civil society board constituency**

For many of our coalitions, the Extractive Industries Transparency Initiative (EITI) is a key focus and our members at the national level are very involved in EITI. National coalitions support the implementation of the initiative and act as a watchdog to ensure it is being done effectively. In many countries, PWYP coalitions help with the dissemination of the information contained within EITI reports, whether by analysing them or going to citizens with the information. Some members also serve as civil society representatives on the national multi-stakeholder groups (MSGs) responsible for EITI implementation. At the international level the Publish What You Pay Secretariat helps coordinate members to act as the civil society watchdog of the initiative.
